Industrial Value Chains, Nearshoring, and Trade Integration

Barranquilla is strengthening its role as a nearshoring destination in the Americas by leveraging its logistics infrastructure, industrial base, and connectivity to regional and international markets.

The city's export-oriented industries, together with its strategic location and trade infrastructure, support investment attraction and integration into global value chains. These conditions create opportunities for companies seeking efficient access to markets while enhancing the region's industrial and trade competitiveness.

Energy Competitiveness

Energy transition is increasingly integrated into Barranquilla's competitiveness agenda, supporting the development of resilient infrastructure and new economic opportunities. The city is emerging as one of Colombia's leading energy hubs, with more than 2,000 companies participating across the energy value chain.

Barranquilla has developed a modern and diversified energy mix. Barranquilla has also been recognized by Germany's Fraunhofer Institute as a potential hub for low-carbon hydrogen and Power-to-X solutions, reinforcing its potential as a hub for large-scale clean energy production, transformation, and export.





Culture, Sports, and the Creative Economy

Barranquilla leverages its cultural identity and sports infrastructure as assets that contribute to international visibility, tourism, and economic development.

The city's creative and cultural ecosystem supports talent development, entrepreneurship, and the growth of creative industries. Together with sports-related assets and events, these strengths contribute to a broader strategy that advances competitiveness, innovation, and economic growth.

REQUIREMENTS TO APPLY

- Possess a professional and academic background relevant to economic development, competitiveness, trade, foreign direct investment, exports, innovation, supply chains, or related fields.
- Be in a position to influence, develop, or implement policies, initiatives, or partnerships that advance economic development and competitiveness within their country or in collaboration with partners across the Americas.
- Be fluent in English.
- Hold a valid passport and, if required, a valid visa for entry into Colombia, and be prepared to provide passport, visa, photograph, and other information required for travel and security procedures.
- Be available to participate fully in the entire ACE Barranquilla program; partial participation is not permitted.
- Be prepared to cover the cost of airfare and hotel accommodations. The ability to do so is an important consideration for the ACE Selection Committee. Limited financial assistance may be available upon request and will be considered on a case-by-case basis.
- Provide proof of health insurance coverage for the duration of the program.
- Previous ACE participants are welcome to apply. To be eligible for selection, returning participants must demonstrate tangible outcomes from their previous ACE participation and have completed all required post-program surveys and consultations in a timely manner.

LOGISTICS AND BUDGET

The Program Organizers will provide the following to selected participants at no cost:

- Local transportation by bus between program sites in the City of Barranquilla.
- VIP access to sites and experts.
- Meals during official program hours of ACE Barranquilla.
- Preferential rates at the official ACE Barranquilla hotel.
- Access to advisory support and facilitators from the City of Barranquilla, stakeholder institutions and authorities, as well as OAS officials.
- Logistical support and dedicated support from the ACE Committee for the duration of the program.

Selected participants will be responsible for:

- Airfare to and from Barranquilla, Colombia
- Booking and covering the cost of their hotel accommodations in Barranquilla for the duration of the program in the ACE selected hotels.
- Airport-hotel transportation and hotel-airport transportation
- Meals outside of program hours
- Other miscellaneous expenses
